LOCATION: Des Moines Rifle and Revolver Club range in Van Meter, IA, about 20 miles west of Des Moines. Take I-80 west from Des Moines to the Van Meter exit, # 113, turn south into town. Cross railroad tracks and take first left to range entrance.

ELIGIBILITY: NRA membership is no longer required for people to compete in NRA tournaments. Competitors will still need to be an NRA member to set **a NRA National Record.**

RULES: Current NRA rules apply.

INDIVIDUAL ENTRIES: **Advance entries are required with payment.** Entries with out payment will not be squadded until payment is made. The match is limited to 80 competitors. Please use entry forms at the bottom of page. **Please fill it out completely.**

Any no shows with out prior notification will be charged a \$5.00 service fee.

SQUADDING TICKETS: All matches will be squaded. Squading tickets for individual matches will be issued at the 600 yard line. Please pick up your packets by 8:30 AM. Squading closes at 8:45 AM.

Be prepared to present your classification card. Walk-ons will be permitted to fill the line up. No additional relays will be added.

CLASSIFICATION: NRA High-power Classification will be used. Unclassified shooters will fire in the Master class.

EMPTY CHAMBER INDICATORS: ECI'S will be required and will be available at the range for \$ 1.50 each.

RIFLES ALLOWED: Current NRA high-power rifle rules will apply. Rifles with rainbow trajectories will not be allowed in the interest of pit safety.

CHALLENGE FEE: \$ 1.00 each

TARGET OPERATION AND SCORING: All competitors will be required to operate targets and score. A qualified substitute target operator will be allowed. Failure to complete target and scoring duties will result is disqualification and loss of match fees.

GENERAL INFORMATION: Lunch and drinking water will not be available. Bathrooms are available. Camping is allowed on the range, and the small-bore range on top of the hill at no charge.

 MATCH 4: REPEAT OF MATCH 3.
 MATCH 5: AGGREGATE OF MATCHES 1-2.
 MATCH 6: AGGREGATE OF MATCHES 3-4.

COURSE OF FIRE: Sat 21 April 2018 at 9:00 AM.
 MATCH 1: 2 SIGHTING SHOTS AND 20 ROUNDS FOR RECORD, PRONE, SLOW FIRE, 600 YARDS, F-CLASS TARGET, 22 MIN. TIME LIMIT. ANY RIFLE, ANY SIGHT.
 MATCH 2: REPEAT OF MATCH 1.
 MATCH 3: REPEAT OF MATCH. 1
 MATCH 4: REPEAT OF MATCH 1

AWARDS: Award groups must contain at least five competitors or they will be combined with the next higher class. If there are fewer than five high masters, they must compete for open awards only. There must be five or more entries for one award, eight or more for two awards, and 11 or more for three awards. Special individual awards will be given for High Woman, High Service Rifle, High Junior and High Senior.
 Tournament 1st, 2nd, 3rd (\$20, 15, 10) Class 1st, 2nd, 3rd (\$5, 4, 3). Match 1st - \$4.- 2nd-\$3.0 -3rd \$2.

DIVISION BY RIFLE: All matches will be divided by service rifle and match rifle.
