Categories: To qualify in the NRA MATCH, PALMA or SERVICE Rifle Categories, you must shoot that type of gun as NRA rules apply ALL day.

RULES: NRA Mid-Range Prone Rules will apply. NRA Mid-Range F-Class Rules Apply.

AWARDS: Cash Awards. There must be 5 competitors in a class or special category to receive awards.

CHALLENGES: A fee of \$2.00 will be charged for each challenge.

PIT SERVICE: Competitors will score and pull targets.

CAMPING: Electrical hook-ups are available. Donations for \$20 for weekend accepted. Gate opens 12:00 P.M. Friday.

RELEASE OF LIABILITY: Any individual attending this match as a competitor or an observer must sign a release form.
