Entry fees will be refunded on a daily basis in the event of a match cancellation. Preregistration fees will be refunded if non-attendance notice is received prior to 4:00 PM on Thursday, 13.

CLASSIFICATION: The NRA classification system will be used in all individual matches. Please have your NRA classification card or temporary score book with you. For class awards there must be at least five entries in that class. If there are less than five, those shooters will be combined with the next higher class. High Masters cannot be combined with any other class and can only compete for Match Winner awards if there are fewer than five shooters in the High Master class. Shooters without a classification card will shoot in the Master/Unclassified (MU) class (rule 19.6). Open and tactical classes will not be combined.

RIFLES: NRA Match rifles and Service Rifles.

RULES: Current NRA High Power rules will govern the matches.

AWARDS: Award payback depends on the number of entries. Forty (40) percent of the Tournament Fee will be awarded to individual competitors. The 10% rule will apply to each class. There must be at least 5 entries in a class for awards. There will be separate category awards for high woman, high senior and high junior if at least 5 in that category. Class and category winners can be the same person if all other criteria are met.

ENTRIES: Advance entries are strongly encouraged and will be given priority entry. Advance entry, accompanied with fees, is required for choice of relay. Entries will be capped at 36 shooters. Advance entries will close at 5:00 P.M. on Thursday, 13 June 2019.

We will hold your entry until one hour before the match begins. If you have not registered by that time your spot will be made available to another participant. Post entries will be accepted up until 6:00 P.M. on Thursday, 20 June, or until the limit of 36 shooters is reached, whichever comes first. Send advance entries with the appropriate fees to:

SQUADDING: Squadding will begin at 0800, June 14,15,16. High masters will be squadded on relay 1 to the extent possible. Pre-registration, accompanied with fees, will be given priority.

ENTRIES CLOSE: Entries close at 0830 and the pit will be sealed at 0845 on Friday, Saturday and Sunday.

Match Friday

Match 1 2 sighters, 20 shots for record, 200 yards, standing, time limit 22 minutes.

Match 2 2 sighters 2 10 shot strings, 200 yards, rapid sitting, 60 seconds per string.

Match 3 2 sighters 2 10 shot strings, 300 yards, rapid prone, 70 seconds per string.

Match 4 2 sighters 20 shots for record, 500 yards, prone, time limit 22 minutes.

Match 5 Aggregate of Match 1 through 4

MATCHES Saturday

Match 1 2 sighters, 20 shots for record, 200 yards, standing, time limit 22 minutes.

Match 2 2 sighters 2 10 shot strings, 200 yards, rapid sitting, 60 seconds per string.

Match 3 2 sighters 2 10 shot strings, 300 yards, rapid prone, 70 seconds per string.

Match 4 2 sighters 20 shots for record, 500 yards, prone, time limit 22 minutes.

MATCHES Sunday

Match 5 2 sighters, 20 shots for record, 200 yards, standing, time limit 22 minutes.

Match 6 2 sighters 2 10 shot strings, 200 yards, rapid sitting, 60 seconds per string.

Match 7 2 sighters 2 10 shot strings, 300 yards, rapid prone, 70 seconds per string.

Match 8 2 sighters 20 shots for record, 500 yards, prone, time limit 22 minutes.

Match 9 Aggregate of Matches 1 through 8

Note: Match 2 & 6 will be fired immediately after Match 1 & 5.

DUTIES: Competitors will be required to score and pull targets. Failure to perform these duties will result in disqualification.

CHALLENGES: There will be a \$2.00 fee for each challenge. A three person jury will be appointed prior to commencement of fire.

CAMPING: The range will be open for camping from 1200 on Thursday, June 13 through 1000 on Monday, June 17th. Electric hook ups for campers are available. Clean outhouses are provided. The Education Center, Lake Cabin and 16 yard shack will be made available for overnight use on Friday, Saturday and Sunday. Contact Jim Fernandez (218) 348-6090 ahead of arrival to ensure access to the camping area.
